When applying you need to verify your identity by a passport or a national ID. Together with your application HHAB also save a photography of you. Your application also includes a PUL agreement with HHAB - See below.

#### **A "HHAB-Card" is your personal card and may not be transferred for the use by another person!**

A "HHAB-Card" is issued free of charge, however, a fee is charged for a replacement if previously issued card has been lost. You usually need a commission in combination with a "HHAB – Card" for access into the port area.

#### *Personal Data Act Agreement*

HHAB ask you to provide certain information about yourself in order to issue a permission that gives you access to facilities belonging to HHAB. HHAB have a demand from state authorities to control access to facilities and terminals which are part of the global maritime security.

The information we intend to collect is your name, including personal identification numbers and/or passport number or national ID number, including nationality and a photography, as well as how, when and where at our facilities you use the permission given to you. We also collect some basic information which give HHAB possibility to communicate directly with you.

The data collected will only be processed by us within HHAB, and if necessary by the authorities, to examine the sequence of events in case of a crime. You decide whether you want to provide any of this information to us. If you don't want allow us to collect any information about yourself, HHAB can't grant you access to our facility.

You have according to § 26 of the Swedish Personal Data Act (1998:204) for free, once per calendar year , after a written signed request addressed to us , be told what personal information about you that we treat and how we treat the collected information. You also have the right, under § 28 of the Personal Data Act, to request correction of the personal data that we hold about you. The data is saved log files from the passage and business systems or equivalent, setting out how, where and when you use your permission to access to our facility.

I agree to HHAB process personal information about me in accordance with the foregoing by signing a request/acknowledgment of my application asking for a "HHAB - Card".
